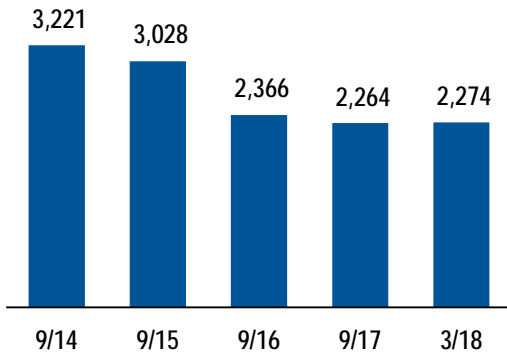

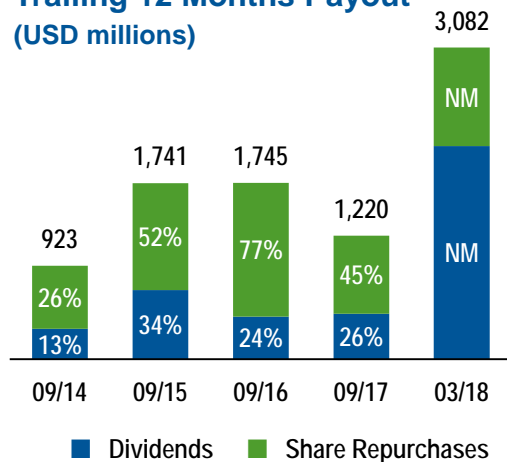

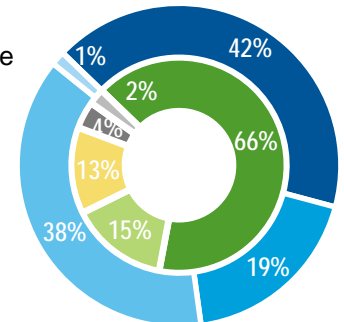

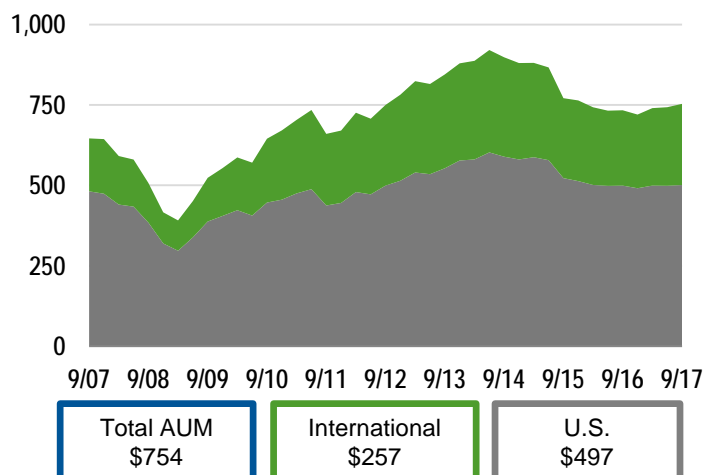

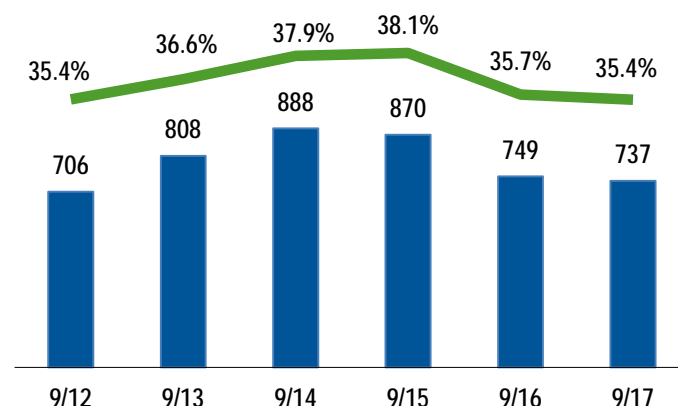

- Globally diversified asset base provides strength through all market cycles
- Strong balance sheet with \$10.4 billion in net cash and investments as of March 31, 2018³
- Annual dividend has increased every year since 1981, and has grown at an average annual rate of 22% since 1984
- Share repurchases have decreased shares outstanding by an average annual rate of 2.7% over the prior five years
- 5-year cumulative payout of about \$7 billion as of September 30, 2017
- Strong investment grade credit ratings (Moody's A2 / Standard & Poor's A+ / Morningstar AA-)
- Distribution relationships with the largest U.S. retail firms average 30 years
