

2022 U.S. Political Engagement Policy and Statement

1 This U.S. Political Engagement Policy and Statement describes the two types of political
2 engagement by the Company. The first is lobbying, which includes both direct communications
3 with government officials by the Company as well as advocacy by other organizations (i.e.,
4 indirect lobbying) that receive financial support from the Company. The second is campaign
5 contributions to candidates for elected office, political parties, political committees, and other
6 organizations that use the contributions for campaign-related purposes.

7 The Company's policy is to participate in public policymaking by informing government officials
8 about our positions on issues significant to the Company and our customers. The Company
9 conducts this lobbying in the context of existing and proposed laws, legislation, regulations, and
10 policy initiatives, and includes commerce, intellectual property, trade, data privacy,
11 transportation, web services, sustainability, and other areas. Relatedly, the Company
12 constructively and responsibly participates in the U.S. electoral process by making campaign
13 contributions. The goal of the Company's political engagement is to promote the interests of
14 the Company and our customers, and the Company makes such decisions in accordance with
15 the processes described in this U.S. Political Engagement Policy and Statement, without regard
16 to the personal political preferences of the Company's directors, officers, or employees. Click

18 **Review and Approval Process**

19 The Company's Vice President of Public Policy reviews and approves each campaign
20 contribution made with Company funds or resources to, or in support of, any candidate, political
21 campaign, political party, political committee, or public official in any country, or to any other
22 organization for campaign-related purposes, to ensure that it is lawful and consistent with the
23 Company's business objectives and public policy priorities. The Company's Senior Vice President
24 and General Counsel, who oversees our global public policy organizations, and the Audit
25 Committee of the Board of Directors annually review this U.S. Political Engagement Policy and
26 Statement, related procedures, and a report on all of the Company's campaign contributions
27 and lobbying expenses, including donations made to other organizations that may engage in
28 indirect lobbying on behalf of the Company.

29 **2022 Political Engagement**

30 In 2022, the Company complied with all applicable regulations requiring public disclosure of
31 corporate political activity.

32 *Campaign Contributions*

33 In 2022, the Company did not make federal contributions to political parties or 527
34 organizations, or in support or opposition of any campaigns, and did not make any federal or
35 state independent expenditures for campaign-related purposes. In 2022, the Company made
36 non-federal contributions to candidates, political committees, 527 organizations, and ballot
37 initiatives in the amounts disclosed in Annex A to this U.S. Political Engagement Policy and
38 Statement.

39 *Amazon Political Action Committee*

40 The Company has formed a political action committee (PAC) funded solely by voluntary
41 contributions from some of the Company's eligible employees and shareholders (and their
42 spouses). The PAC's activities are subject to federal regulation, including detailed public
43 disclosure requirements. The PAC files regular public reports with the Federal Election
44 Commission (FEC), and campaign contributions to and by the PAC are required to be disclosed.

47 *U.S. Lobbying Activities*

48 In 2022, the Company spent approximately \$19.69 million on federal lobbying activities, which
49 are reported to the House and Senate:

51 In 2022, our spending related to the Company's government relations efforts in all states (non-
52 federal) and Washington, D.C., was approximately \$7.06 million. Specific amounts spent per
53 jurisdiction are included in Annex A to this U.S. Political Engagement and Policy Statement, as
54 disclosed on applicable state and local websites, such as those maintained by secretaries of
55 state, state ethics and public disclosure commissions, state legislatures, and other state and
56 local authorities.

57 *Trade Associations, 501(c)(4) Social Welfare and Other Organizations*

58 The Company contributes to certain trade associations, coalitions, charities, and 501(c)(4) social
59 welfare organizations, many of which engage in indirect lobbying on behalf of the Company by
60 communicating with policymakers on issues important to their members. All organizations
61 receiving such payments of \$10,000 or more made through the Company's Public Policy Office
62 in 2022 are disclosed in Annex A to this U.S. Political Engagement Policy and Statement. The
63 Company may not agree with all the positions of each organization, its leaders, or its other
64 supporters, but believes that the Company's support will help advance policy objectives aligned
65 with our interests.
