


Q3 2022 Financial Results Conference Call Slides








Long-Term Goal – Efficiently Managing Dilution




Net Sales – TTM




Operating Income



Operating Income – TTM




Net Income (Loss) (1)



Net Income – TTM




Segment Results – North America




TTM Net Sales \$304.9B
