Appointment of Executive Officers

On April 13, 2021, Univision Holdings, Inc. agreed to purchase certain of Grupo Televisa S.A.B. (“Televisa”)’s content and media assets for a total value of \$4.5 billion (the “Televisa-Univision Transaction”). The Televisa- Univision Transaction is expected to close in 2021.

Univision Communications Inc. (the “Company”) announced the appointment, effective August 2, 2021, of Jose Tomas as Chief Administrative Officer, a new position. Mr. Tomas will continue in this role as Chief Administrative Officer following the successful closing of the Televisa-Univision Transaction.

Mr. Tomas, 53, previously served as a principal and managing partner at BrandSparc. Prior to his role at BrandSparc, he worked as Senior Vice President of Global Human Resources at General Motors and has worked in various capacities at companies such as Burger King and Publix, among others. Mr. Tomas holds an M.S. in Human Resources Management and a B.B.A. in Management from Florida International University’s College of Business Administration.

The Company announced the appointment, effective August 26, 2021, of Pilar Ramos as General Counsel and Corporate Secretary. Ms. Ramos will continue in this role as General Counsel and Corporate Secretary following the successful closing of the Televisa-Univision Transaction.

Ms. Ramos, 48, previously served in several leadership roles at Mastercard International Incorporated (“Mastercard”), most recently as Executive Vice President, General Counsel of North America. Prior to joining Mastercard, Ms. Ramos served as Assistant General Counsel at DIRECTV Latin America and prior to that as General Counsel of DeRemate.com. Before that she was at Simpson Thacher & Bartlett LLP. She holds a J.D. from the University of Pennsylvania Law School and a B.A. from the University of Pennsylvania. Amy Tenbrink and Glenn Dryfoos had been acting as Co-Interim General Counsels prior to Ms. Ramos’s appointment.
