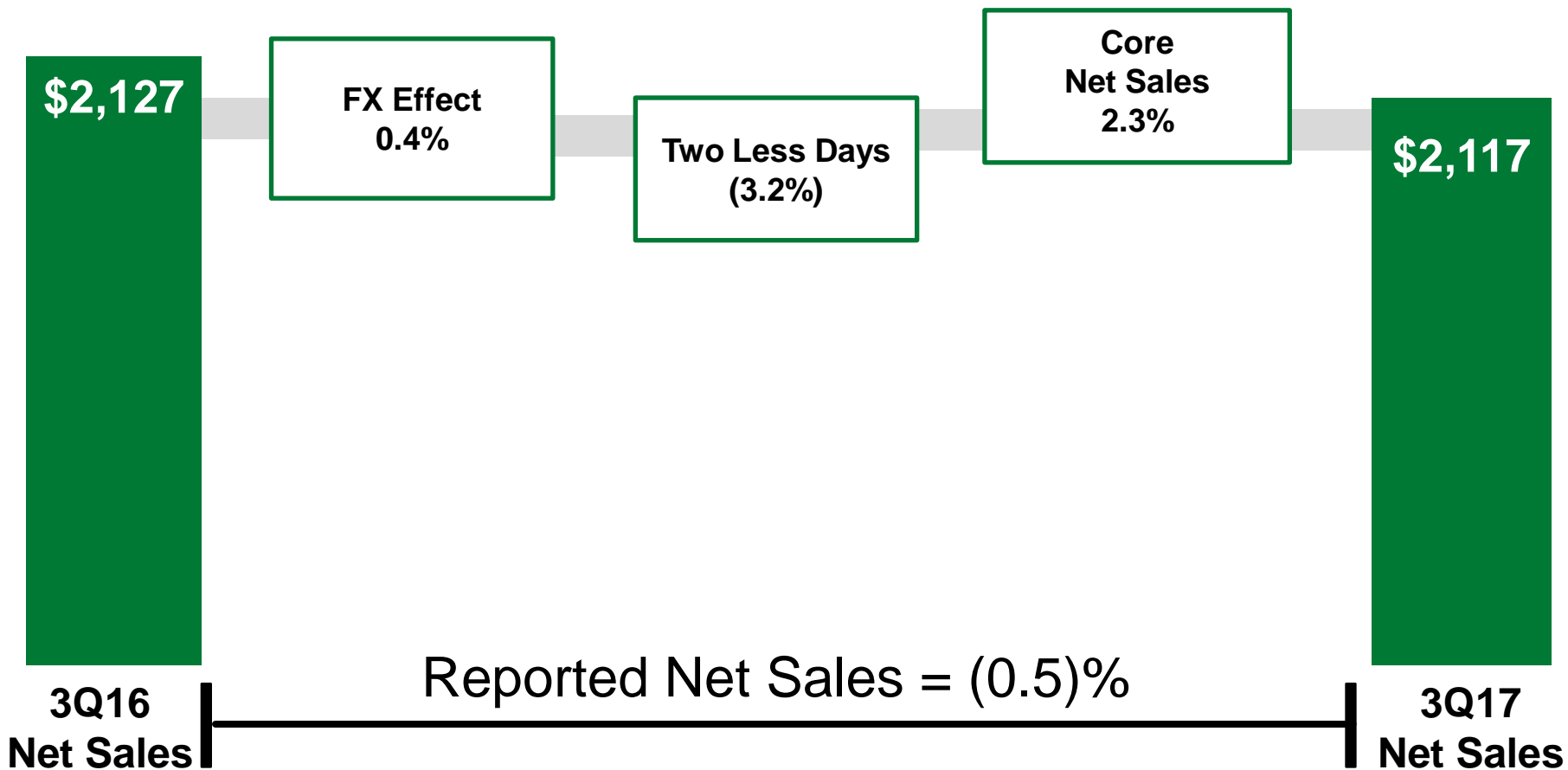

# 3Q17 Highlights and 2017 & 2018 Outlook



## 3Q17 Highlights:

- Packaging: strong 3Q sales
- Facility Solutions: strong 3Q sales
- Print and Publishing: difficult 3Q; secular challenges expected to continue
- Integration and synergy capture on track, but pace slowing (as expected)
  - Warehouse consolidation and operating system conversion ongoing
    - Complexity leading to higher operating expenses
- Continued investment in growth businesses
- All American Containers acquisition

## 2017 Outlook:

- 2017 Adjusted EBITDA is expected to be \$170 - \$175 million
- 2017 Free Cash Flow is expected to be near zero

## 2018 Early Outlook:

- 2018 Adjusted EBITDA is expected to improve over 2017
- 2018 Free Cash Flow is expected to improve over 2017

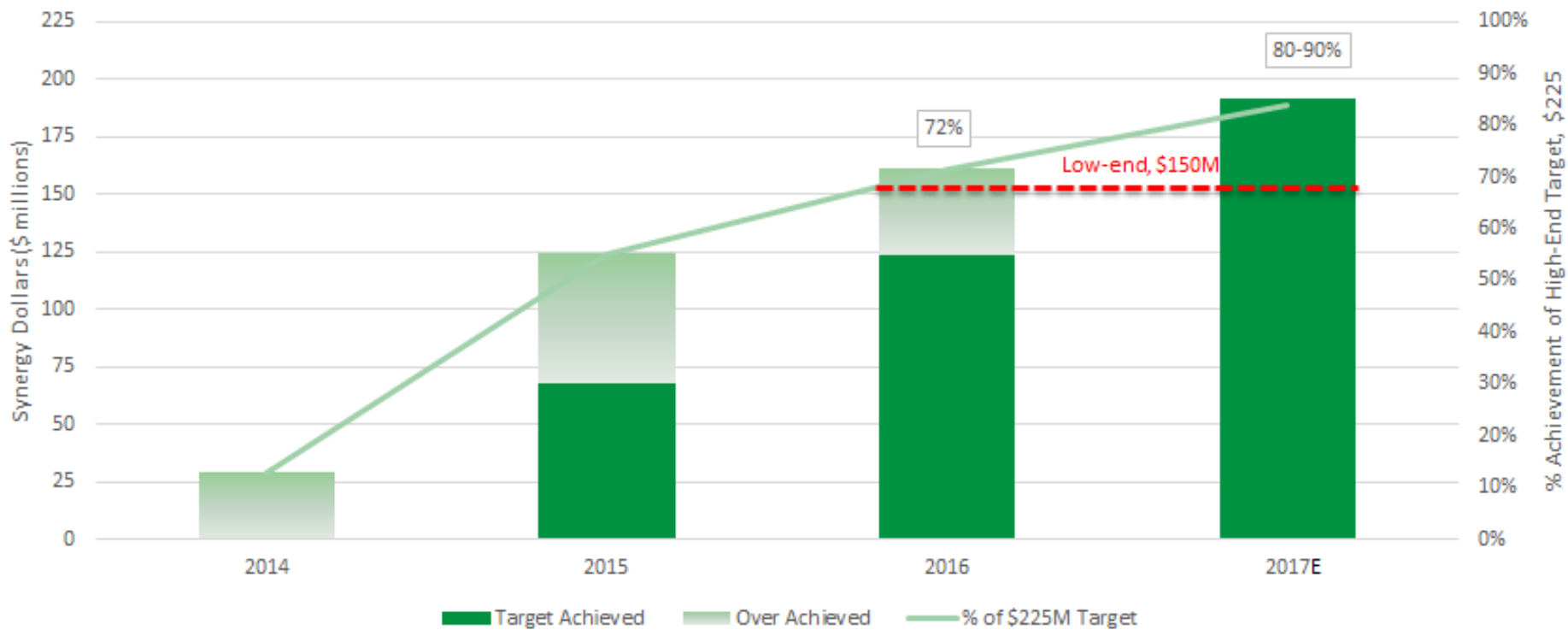

# Asset Based Loan Facility & Capital Allocation



## Capital Structure

- At the end of September 2017:
  - The borrowing base availability for the ABL facility was ~ \$1.2B
  - \$969M drawn against the ABL facility
  - \$272M of available borrowing capacity
- Net debt to Adj. EBITDA: 5.4x for the trailing 12 months<sup>1</sup>

## Capital Allocation

- Capital Allocation Priorities:
  - Invest in the Company
    - YTD: CapEx totaled ~ \$26M, with ~ \$12M related to integration
    - Expect 2017 incremental CapEx for integration projects of \$10M - \$20M
    - Ordinary course 2017 CapEx expected to be \$20M - \$30M
  - Pay down debt
  - Invest in growth (organic and inorganic)
  - Return value to shareholders

# Appendix: Reconciliation of Non-GAAP Financial Measures



We supplement our financial information prepared in accordance with GAAP with certain non-GAAP measures including Adjusted EBITDA (earnings before interest, income taxes, depreciation and amortization, restructuring charges (income), acquisition and integration expenses and other similar charges including any severance costs, costs associated with warehouse and office openings or closings, consolidation, and relocation and other business optimization expenses, stock-based compensation expense, changes in the LIFO reserve, non-restructuring asset impairment charges, non-restructuring severance charges, non-restructuring pension charges, fair value adjustments on the contingent liability associated with the Tax Receivable Agreement ("TRA") and certain other adjustments) because we believe investors commonly use Adjusted EBITDA and these other non-GAAP measures as key financial metrics for valuing companies. In addition, the credit agreement governing our asset-based lending facility permits us to exclude the foregoing and other charges in calculating "Consolidated EBITDA", as defined in the facility. We approximate foreign currency effects by applying the foreign currency exchange rate for the prior period to the local currency results for the current period.

Adjusted EBITDA and these other non-GAAP measures are not alternative measures of financial performance under GAAP. Non-GAAP measures do not have definitions under GAAP and may be defined differently by, and not be comparable to, similarly titled measures used by other companies. As a result, we consider and evaluate non-GAAP measures in connection with a review of the most directly comparable measure calculated in accordance with GAAP. We caution investors not to place undue reliance on such non-GAAP measures and to consider them with the most directly comparable GAAP measures. Adjusted EBITDA and these other non-GAAP measures have limitations as analytical tools and should not be considered in isolation or as a substitute for analyzing our results as reported under GAAP.
