To add an owner, the signature(s) of the current owner(s) must be a specimen signature for the new owner is required along with their Social Security number, date of birth, current address and phone number. To remove an owner due to death, a certified copy of the death certificate, a completed W-9 form if the Social Security number will change, and a letter of instruction signed by the surviving owner are required. If the deceased is the only owner, then the executor must sign the letter of instruction, submit a certified copy of the death certificate, and submit a copy of the certified letter of Testamentary or other letters of authority. Wills are not acceptable. To change your name, a copy of the marriage certificate, or original or certified copies of other legal documents substantiating the name change must be submitted. To change a Social Security/tax ID number requires a completed W-9 form.
