## Senior Housing Properties Trust Announces Quarterly Common Dividend

NEWTON, Mass.--(BUSINESS WIRE)-- Senior Housing Properties Trust (NYSE: SNH) today announced it has declared a regular quarterly common share dividend of \$0.39 per common share (\$1.56 per share per year). The next quarterly dividend will be paid to common shareholders of record as of the close of business on January 22, 2016 and distributed on or about February 23, 2016.

Senior Housing Properties Trust is a real estate investment trust, or REIT, which owns senior living communities, medical office buildings and wellness centers throughout the United States. SNH is managed by the operating subsidiary of The RMR Group Inc. (NASDAQ: RMR), an alternative asset management company that is headquartered in Newton, MA.
